**Community Valley Bank to Host Groundbreaking Monday, July 19 at 9:30 A.M.
(Corner of Main and South 3rd Street Brawley, CA 92227)**

The new CVB branch offices are expected to be open for business by the end of this year. During construction, CVB will continue serving its customers out of the current branch, which is located at 310 Main Street.

"We, along with the city and the community-at-large, are enthusiastic about seeing the City of Brawley grow and prosper. This project is a testament to the city's focus on economic development," said Jon Edney, Chairman of the bank's Board of Directors.
